

The Trade is hereby informed that the Central Board of Excise and Customs (CBEC), has issued Notification No. 1/2017-Central Tax to Notification No. 6/2017-Central Tax, all dated 19.06.2017 which have come into force with effect from 22.06.2017. Further, consequently Trade Notice No. 03/2017 dated 22.6.2017 has been issued by the Chief Commissioner of Central Tax (Jaipur Zone), Jaipur, specifying the jurisdiction of various Central Tax Commissionerates within Jaipur Zone.
