3. The promotion of the aforesaid officer is made **on in situ (as is where is) basis** i.e. such Inspector, Group 'B' (Non-Gazetted) shall continue to work at the same place where he is presently posted till his posting orders for Inspector is issued by the Competent Authority.

4. On promotion, benefit of option for fixation of pay in the promotional post, if admissible, shall be available to the officer named above in terms of provisions contained in the DoPT's O.M. No. DOPT-1667551701810 dated 13.09.2022. He may exercise the option, if benefit of the same is admissible, within one month from the date of their promotion. No request for condonation of delay in submitting the option after the stipulated period will be entertained.
5. The promotion of the aforesaid officer is subject to final outcome of O.A. No. 597/2026 filed by Shri Bhupendra Mahla & others before Hon'ble CAT Jaipur.

The promotion of the aforesaid officer is also subject to receipt of final instructions of Board in the matter of promotion of Stenographer Grade-II to the grade of Stenographer Grade-I during the period from 22.12.2010 i.e. date of merger of cadres of Stenographers to 21.09.2015 i.e. date of new Recruitment Rules of Stenographer Grade-I.
7. The aforesaid promotion is also subject to the final outcome with reference to Board's letter F. No. A.32022/67/2018-Ad.IIIA dated 12.06.2025.
8. The promotion of the aforesaid officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the Jarnail Singh batch of cases in the matter of reservation in promotion.
9. The promotion of the aforesaid officer is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.
10. The officer should be allowed to join the promoted post, only if clear from the vigilance angle.
