
Consequent upon the recommendations of the DPC Meeting held on 24.10.2019 for promotion to the grade of Assistant Sub-Inspector (Weapons), Group "C", Shri Hanuman Sahai S/o Mohari Lal (DOB - 10.03.1962) (SC), Head Havaldar of GST, Central Excise & Customs, Jaipur Zone, Jaipur is hereby promoted to the grade of Assistant Sub-Inspector (Weapons), Group "C" in Level-3 of Pay Matrix Rs. 21,700/- - Rs. 69,100/- plus other allowances, as admissible, on regular basis, with effect from the date of assumption of charge of the promoted post i.e. in the grade of Assistant Sub-Inspector ( Weapons), "Group C", at the place of posting in Para 2 below:

2. Consequent upon the said promotion to the grade of Assistant Sub-Inspector (Weapons), "Group C", Shri Hanuman Sahai is allocated to the Customs (Prev.) Commissionerate, Jodhpur, Hqrs., at Jaipur. Further specific posting of Shri Hanuman Sahai, on promotion post, will be decided by the Commissioner of Customs, Customs (Prev.) Commissionerate, Jodhpur, Hqrs. at Jaipur.

3. Consequent upon the said promotion, the above mentioned officer, if he is already not drawing the pay scale in Level-3 of Pay Matrix Rs. 21,700/- - Rs. 69,100/- and above, under the MACP Scheme, may exercise option for fixation of his pay under FR-22(1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. The promotion of the said officer is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.

5. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion / seniority.
