Shri Sanjeev Kumar Mittal, Inspector was considered for grant of promotion to the grade of Superintendent, Group 'B' (Gazetted) by the DPC held on 10.09.2014. Pending Criminal Case No. 50/2019 (Rajasthan State Vs. Mahesh Kumar Gautam and others), the DPC kept its findings in sealed cover in terms of DoPT's O.M. No.22011/4/91-Estt. (A) dated 14.09.1992. Consequent upon acquittal in the aforesaid Criminal Case vide Order dated 15.09.2022 of the Hon'ble Court ACJM No. 1, Bikaner, the sealed cover prepared by the DPC dated 10.09.2014 has been opened by the competent authority. As per findings of DPC dated 10.09.2014, Shri Sanjeev Kumar Mittal, Inspector Customs Commissionerate, Jodhpur (Hqrs. at Jaipur), is hereby promoted on regular basis to the grade of Superintendent Group 'B' (Gazetted) (in the pay band / scale of Rs.9300-34800 (PB-2) with corresponding grade pay of Rs.4800/-) w.e.f 30.09.2014 on notional basis when his junior Shri Ripu Daman Singh, Inspector joined as Superintendent, Group 'B' on regular basis from the select panel prepared by the aforesaid DPC held on 10.09.2014.

2. Since, the acquittal of Shri Sanjeev Kumar Mittal, Inspector in aforesaid Criminal Case is on the basis of benefit of doubt and rajinama, therefore, in terms of para-3 of the DOPT's O.M. No.22011/4/91-Estt. (A) dated 14.09.1992, he will not be entitled for arrears of pay on grant of said notional promotion.


3. Consequent upon the promotion, the officer is allocated to the Commissionerate as below :

This issues with the approval of the competent authority.


