**ESTABLISHMENT ORDER NO. 134/2021**

Shri Hari Narayan Meena, Head Hawaldar (DOB – 12.11.66), presently posted at CGST (Hqrs.), Jaipur was granted 2<sup>nd</sup> MACP w.e.f. 16.08.2011 in the pay scale of Rs. 5200-20200 with Grade Pay of Rs. 2000 in PB-1 after completion of 20 years of regular service under MACP Scheme vide this office Establishment Order No. 93/2011 dated 16.09.2011 .

2. Since, a period of 190 days has been declared as 'dies non' prior to 16.08.2021 in respect of Shri Hari Narayan Meena, Head Hawaldar vide Order F.No. II-39(11) Vig./JP-II/2010/156 dated 25.04.2016 issued by the Additional Commissioner (P&V), Customs (Prev.) Jodhpur, therefore, in terms of Ministry's letter F.No. A-26017/94/2012-Ad.II A dated 25.09.2012, 2<sup>nd</sup> MACP granted to him w.e.f. 16.08.2011 has been reviewed by the Departmental Screening Committee held on 18.11.2021. Accordingly, in partial modification to Establishment Order No. 93/2011 dated 16.09.2011, Shri Hari Narayan Meena, Head Hawaldar is granted 2<sup>nd</sup> MACP in the pay scale of Rs. 5200-20200 with Grade Pay of Rs. 2000 in PB-1 w.e.f. 22.02.2012 instead of 16.08.2011 after postponement of relevant 'dies-non period of 190 days.

3. All the other conditions as contained in the said ET Order No. 93/2011 dated 16.09.2011 shall remain unchanged.

4. This issues with the approval of the competent authority.
