ESTABLISHMENT ORDER NO. 143/2021

Shri Aftab Miyan, Driver Grade-II (DOB - 23.11.1969), CGST & Central Excise (Hqrs.) Jaipur is hereby promoted to the grade of Driver Grade-I, Group 'C', Non Gazetted (Non-Ministerial) on regular basis in the pay scale of Rs. 5200-20200 (PB-1) with grade pay of Rs. 2800/- (revised as Level-5 in Pay Matrix Rs. 29200-92300) with effect from the date of assumption of charge of post, not before 01.01.2022, in pursuance of this order .

2. Consequent upon the said promotion, the above mentioned officer, if he is already not drawing the pay scale of Rs. 5200-20200 (PB-1) with grade pay of Rs. 2800/- (revised as Level-5 in Pay Matrix Rs. 29200-92300) and above, under the MACP Scheme, may exercise option for fixation of his pay under FR-22 (1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

3. The said officer should submit his report on regular promotion to the concerned controlling officer under intimation to this office. He is posted at his present place of posting on the said promotion to the grade of Driver Grade-I till further orders.

4. The promotion of the said officer is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

5. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.
