1. Please inform whether ICT-transferred Stenographers posted in Jaipur CGST Zone are being repatriated to their parent zones on the basis of the July 2023 CBIC letter. If yes, kindly provide:
 - (a) copies of such directions/orders,
 - (b) File noting approving such repatriation, and
 - (c) Reasons for adopting a different approach in Jaipur CGST Zone as compared to Delhi CGST Zone.
2. Please provide the rule position and legal justification under which ICT-transferred officers are being treated differently in different CGST Zones despite common Recruitment Rules and common CBIC instructions.
3. Kindly provide zone-wise details of ICT-transferred Stenographer Grade-I officials who have been considered under OTR for promotion to Inspector in vacancy year 2026, including:
 - (a) Name of officer,
 - (b) Parent Zone,
 - (c) Present Zone,
 - (d) Date of ICT, and
 - (e) Whether promoted under OTR or not.

Information Provided :-

Point 1 and 2 :- CBIC, New Delhi vide letter F.No. A.32012/43/2022-Ad.IIIA dated 09.01.2024 has informed Jaipur Zone that ICT cannot be allowed in Steno Grade-II after issuance of RRs, 2011 & directed CCA to take corrective action. The ICT steno officers approached to the Hon'ble CAT, Jaipur Bench & filed an O.A. No. 53/2024 titled Manoj Kumar Bairwa Vs. Revenue. The Hon'ble CAT, Jaipur Bench vide order dated 31.01.2024 directed to maintain status quo with regards to applicants in pursuance of order dated 09.01.2024 till next date of hearing. The next date of hearing in the matter has been fixed for 11.08.2026. Copies of Board's letter dated 09.01.2024 & Hon'ble CAT, Jaipur Bench's Order dated 31.01.2024 are enclosed.

Subject: ICT in the grade of Group 'B' (Non-Gazetted) and Group 'C' in light of Recruitment Rules for the post concerned - reg.

महोदय/ Sir,

मुझे उपर्युक्त विषय पर आपके कार्यालय पत्र F.No.GCCO/II/3/Tran/35/2021-Admn दिनांक 20.12.2023 का संदर्भ लेने का निर्देश दिया गया है।

I am directed to refer to your office letter F.No. GCCO/II/3/Tran/35/2021-Admn dated 20.12.2023 on the above-mentioned subject.

2. इस संबंध में, यह कहा गया है कि स्टेनो ग्रेड-II के भर्ती नियम, 2011 के अनुसार, आईसीटी के लिए कोई विशेष प्रावधान नहीं है और प्रत्येक आयुक्तालय का अपना अलग संवर्ग होगा। किसी विशेष प्रावधान के अभाव में, भर्ती नियम, 2011 जारी होने के बाद स्टेनो ग्रेड-II में आईसीटी की अनुमति नहीं दी जा सकती है। इसलिए, यह अनुरोध किया जाता है कि सी.सी.ए. द्वारा आवश्यक सुधारात्मक कार्रवाई की जाए और इस संबंध में की गई कार्रवाई की रिपोर्ट बोर्ड को प्रस्तुत की जाए।

In this regard, it is stated that as per Recruitment Rules, 2011 of Steno Grade-II, there is no special provision for Inter Commissionerate Transfer and each Commissionerate will have its separate cadre. In absence of any special provision, ICT cannot be allowed in Steno Grade-II after issuance of RRs, 2011. Therefore, it is requested that necessary corrective action may be taken by the CCA and an action taken report in this regard may be submitted to the Board.
