2. Provide the number of Backlog vacancies (zone-wise) for Assistant Commissioner (who will be promoted from Superintendent to Assistant Commissioner) in the Persons with Disability (PWD) category in the central GST department under the CBIC
3. Chief Commissioner, CGST & C.Ex. Mumbai /Nagpur /Pune /Goa, please, provide the copies of proposal submitted to DGHRD in response to DGHRD's letter F. No. 8/B/20/HRD (HRM-I)/Misc/2023/9459 Dated: 29.12.2023 issued by Additional Director General (HRM-I), DGHRD New Delhi. Information Provided :-

“Point No. 1 : Presently, 2 backlog vacancies are available in the grade of Superintendent for PwBD.

Point No. 6 : In CGST Jaipur Zone, Jaipur, there is no effect of the DoPT’s O.M. dated 28.12.2023 in any of the cadres except the cadre of Superintendent. Review DPC to extend the benefit of reservation in promotion on notional basis w.e.f. 30.06.2016 in light of DoPT’s O.M. dated 28.12.2023 in the grade of Superintendent, has been held. The requirement for creation of supernumerary posts in the grade of Superintendent in Jaipur Zone had been sent to the Board and sanction of the same is awaited.

Point No. 10 : The reservation in promotion to PwBD category officers is being granted in CGST Jaipur Zone as per provisions contained in DoPT’s OM. dated 17.05.2022 & other related OMs.”
