**SUB-RELEASING OF ARREAR OF PAY AND ALLOWANCES ON GRANTING OF NON FUNCTIONAL UP-GRADATION IN COMPLIANCE OF THE ORDER DTD 14/03/2019 PASSED BY THE HON'BLE CAT JAIPUR-REG.**

*We have issued this order after seeking permission from CBIC, who is to have take approval of DOE. Res. 2. 4/11/19*

Sir

It is submitted that office of the Chief Commissioner, CGST (North Zone) Jaipur has issued Establishment Order No. 46/2019 dtd 26/07/2019 consequent upon approval granted by the Board in consultation with the Department of Expenditure, New Delhi in compliance of the orders dtd 14/03/2019 passed by the Hon'ble CAT Jaipur to grant Non -Functional Upgradation to the grade-5400/-in PB-2 (Revised as Level-9 in Pay matrix Rs. 53100-167800) to those employees (total 219 employees) who have completed 4 years of regular service in pre-revised Grade Pay of Rs. 4800/-(PB-2) or 01/01/2006 (date of implementation of NFU Scheme), whichever is earlier. Copy of order is enclosed herewith for your perusal.

Pay of all 219 employees has been revised by their respective offices and bills of arrear of pay and allowances have been submitted to this office for remitting/releasing of payment. Copy of some pay fixations orders are also enclosed herewith for your perusal.

As per Para-2 of OM No. 28027/9/99-Estt.(A) dtd 1<sup>st</sup> May 2000 issued by Department of Personnel and Training, Ministry of Personnel, Public Grievances and Pensions, whenever there is any Court order against the Government of India instruction on service matters, the administrative ministry/Department/Office shall consult the Department of Legal Affairs and the Department of Personnel and Training on the question of filing appeal against such an order, as far as possible, well in time, that is before the time limit, if any, prescribed in such order or before the time limit for filing appeal. No such orders shall be implemented by the concerned Departments/Ministries without first referring the matter to the Department of Legal Affairs for advice and to Department of Personnel and Training.

On perusal of Establishment Order No. 46/2019 dtd 26/07/2019 issued by office of the Chief Commissioner, CGST (North Zone) Jaipur, it is revealed that matter was not referred to the Department of Legal Affairs for advice and to Department of Personnel and Training before implementation of CAT orders.

Matter is being referred to HQrs New Delhi for your perusal before releasing of arrear of pay and allowances of the all 219 employees to avoid any audit objection in later stage. It is requested to issue guideline/approval on the above matter.
