Notice of termination of service issued under Rule 5 (1) of the Central Civil Services (Temporary Service) Rules, 1965.

Whereas, Sh. Gourav Sandal, Inspector while posted as such in the office of the Assistant Commissioner of Customs, ICD, Khatuwas, vide his application dated 14.08.2019 sought one day casual leave for 16.08.2019 with permission to leave Hqrs. He was required to join his duties on 19.08.2019, but he had not joined his duty. However, he submitted an application dated 20.08.2019, through whatsapp, for medical leave for three to four weeks giving reasons that he had met with an accident on 18.08.2019 and doctor had advised him rest for the said period. Along with the request on whatsapp, he also submitted medical certificate dated 20.08.2019 issued by Dr. Kultaran Singh Chadha of Chadha Clinic, Clinical Laboratory & Immunisation Centre, Kothi No. 23.08, Sector-35-C, Chandigarh.

2. And whereas, Sh. Sandal vide his another letter dated 02.10.2019, sent through whatsapp, again intimated that his medical condition is improving and doctor had advised rest for further period of three to four weeks, but no medical certificate was submitted. However, on being asked, Sh. Sandal submitted medical certificate dated 22.10.2019, through whatsapp, issued by the same doctor. Thereafter, neither any communication was received from Sh. Sandal nor he joined his duties and remained unauthorisedly absent from office.

3. And whereas, Shri Gourav Sandal, Inspector was required to join his duties after availing of leave sought for by him and also to submit valid medical certificate in support of his claim for sanction of leave by the competent authority. But he neither joined his duties nor submitted any medical certificate and leave application for his past absence. Moreover, letters dated 15.01.2020, 04.02.2020, 18.02.2020 sent to his declared address for joining of duties & submission of valid medical certificates, were not replied by Sh. Sandal. The said letters were also sent through whatsapp on mobile No. 8588800003 of Sh. Sandal, but no response was received. Further, letter dated 18.02.2020 was sent to two known addresses of Sh. Sandal at Talwandi Bhai(Dist-Ferozpur) & Gurgaon (Haryana) through speed-post, but the same were received undelivered.


4. Therefore, considering all the above facts, a Memorandum F.No.II-39(7)Cus/Vig/JPR/2020/384-385 dated 20.03.2020 was issued to Shri Gourav Sandal. wherein he was asked to explain the reasons and circumstances under which he remained unauthorisedly absent from office and failed to comply with the directions of the controlling authority to join his duty and submit medical certificate in support of his claim for sanction of leave by the competent authority. He was also asked to explain as to why disciplinary proceedings should not be initiated against him for the aforesaid misconduct under CCS (CCA) Rules, 1965. The Memorandum was sent to him through speed-post and delivered to him on 30.03.2020.

5. Whereas, Shri Gourav Sandal failed to submit any reply to the Memorandum dated 20.03.2020 within stipulated time period. Instead Shri Gourav Sandal tendered his resignation from services, which was received on 17.07.2020.

6. Whereas, after considering the Memorandum dated 20.03.2020 issued to Shri Gourav Sandal, Inspector and as per available records, the Commissioner, Customs, Jodhpur (hqrs. at Jaipur) found that no reply to the said Memorandum was submitted by Shri Gourav Sandal, Inspector and that instead, he has tendered his resignation vide letter dated 'Nil', received in the office on 17.07.2020. The Commissioner, Customs, Jodhpur (hqrs. at Jaipur) found that Shri Gourav Sandal, Inspector remained unauthorisedly absent from office from 16.08.2019 to 17.07.2020 (date of his resignation).

7. Whereas, Shri Gourav Sandal had 73 days half pay leave available in his leave account, therefore, the same was sanctioned from 16.08.2019 to 27.10.2019 (total 73 days) vide sanction order date 12.04.2021 issued by A.O.(DDO), Customs, Jodhpur (hqrs. at Jaipur). Further, the Commissioner, Customs, Jodhpur (hqrs. at Jaipur) vide order dated 23.07.2021 ordered that the remaining period of unauthorized absence i.e. from 28.10.2019 to 17.07.2020 (date of receipt of his resignation). i.e. a period of 264 days, shall be treated as Dies-non for which Shri Gourav Sandal, Inspector shall not be entitled for any pay and other allowances and this period shall not be included while calculating his qualifying service for pensionary benefits as well as other benefits otherwise admissible to him.

8. Whereas, I find that Sh. Gourav Sandal, Inspector is still absconding from duty. Therefore, in pursuance of sub-rule (1) of rule 5 of the Central Civil Services (Temporary Service) Rules, 1965, I hereby give notice to Shri Gourav Sandal, Inspector that his services shall stand terminated with effect from the date of expiry of a period of one month from the date on which this notice is served on or, as the case may be, tendered to him.
