ESTABLISHMENT ORDER NO. CCU 28/2024

Shri Sanjeev Kumar Mittal, Inspector was considered for grant of 1st Financial Upgradation under ACP Scheme w.e.f. 07.02.2006 by the DSC held on 07.02.2006. Pending Criminal Case No. 50/2019 (Rajasthan State Vs. Mahesh Kumar Gautam and others), the DSC kept its findings in sealed cover in terms of DoPT's O.M. No.22011/4/91-Estt. (A) dated 14.09.1992. Consequent upon acquittal in the aforesaid Criminal Case vide Order dated 15.09.2022 of the Hon'ble Court ACJM No. 1, Bikaner, the sealed cover prepared by the DSC dated 07.02.2006 has been opened by the competent authority. As per findings of DSC dated 07.02.2006, Shri Sanjeev Kumar Mittal, Inspector Customs Commissionerate, Jodhpur (Hqrs. at Jaipur), is hereby granted scale of pay of Superintendent, Group 'B' i.e. Rs. 7500-250-12000 {revised in the pay band / scale of Rs.9300-34800 (PB-2) with corresponding grade pay of Rs.4800/-} notionally w.e.f. 07.02.2006 as the first financial upgradation under the Assured Career Progression Scheme.


2. Since, the acquittal of Shri Sanjeev Kumar Mittal, Inspector in aforesaid Criminal Case is on the basis of benefit of doubt and Rajinama, therefore, in terms of para-3 of the DOPT's O.M. No.22011/4/91-Estt. (A) dated 14.09.1992, he will not be entitled for arrears of pay on grant of first financial upgradation under the ACP Scheme on notional basis.

3. The financial upgradation under the ACP Scheme shall be purely personal to the employee and shall have no relevance to his seniority position. As such, there shall be no additional financial upgradation for the senior employee on the ground that the junior employee in the grade has got higher pay scale under the ACP Scheme.

4. On upgradation under the ACP Scheme, pay of an employee shall be fixed under the provisions of F.R. 22(1)a(1) subject to a minimum financial benefit of Rs. 100/- as per the DoPT's O.M. No. 1/6/97-pay.I dated July, 5 1999. The financial benefit allowed under the ACP Scheme shall be final and no pay-fixation benefit shall accrue at the time of regular promotion i.e. posting against a functional post in the higher grade i.e. Superintendent, Group 'B'. The option of pay fixation in the next higher grade based on the date of increment may be allowed. As per the Ministry's instructions, option for pay fixation in the higher pay scale may be

exercised by the officer within one month from the date of issuance of this order, thereafter, no such option shall be entertained.

This issues with the approval of the competent authority.


