2. आवेदक द्वारा पूर्व में भी अपने विभिन्न आरटी आई आवेदनों द्वारा पिछले वर्षों के सन्दर्भ में इस तरह की अनेक सूचनाएं माँगी गयी हैं, जिनका समुचित निस्तारण इस कार्यालय द्वारा किया गया है। इस प्रकार की सूचनाएं तैयार करने से सरकारी कार्यालय का उपयोगी समय नकारात्मक रूप से प्रभावित होगा तथा सामान्य कामकाज पर भी विपरीत असर पड़ेगा। पूरे विभाग से सम्बंधित सूचना अलग अलग आवेदनों से मांगना पूरे विभाग में कार्यालय के समय एवं श्रम की अनावश्यक क्षति है। ऐसा करना कार्यालय के संसाधनों का अनानुपातिक रूप से विचलित करने से सूचना का अधिकार अधिनियम की धारा 7(9) से भी आक्षेपित है। माननीय दिल्ली उच्च न्यायालय के रिट पिटिसन सं. 7976/2020 में निर्णय दिनांक 12.01.2021 में प्रतिपादित सिद्धांत - *"This court is of the opinion that whenever information is sought under the RTI Act, the disclosure of interest in the information sought would be necessary"* की कसौटी पर मूल्यांकन करने पर भी यह लगता है कि उक्त आवेदन में वांछित सूचना के सम्बन्ध में लोक हित की पुष्टि नहीं होती है।

3. माननीय उच्चतम न्यायालय द्वारा सिविल अपील संख्या 6454/ 2011, Central Board of Secondary Education & Anr. बनाम Aditya Bandopadhyay & Ors. मामले में प्रदत्त निर्णय दिनांक 09.08.2011 में निम्नलिखित सिद्धांत प्रतिपादित किया है:- *"Indiscriminate and impractical demands or directions under RTI Act for disclosure of all and sundry information (unrelated to transparency and accountability in the functioning of public authorities and eradication of corruption) would be counter-productive as it will adversely affect the efficiency of the administration and result in the executive getting bogged down with the non-productive work of collecting and furnishing information. The Act should not be allowed to be misused or abused, to become a tool to obstruct the national development and integration, or to destroy the peace, tranquility and harmony among its citizens. Nor should it be converted into a tool of oppression or intimidation of honest officials striving to do their duty. The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of a public authorities prioritising 'information furnishing', at the cost of their normal and regular duties."*

4. आवेदक द्वारा उपर्युक्त आरटीआई आवेदनों में वांछित सूचनाएं प्रदान करने में इस कार्यालय के संसाधन प्रतिकूल रूप से प्रभावित हो रहे हैं, अतः आवेदक के उपर्युक्त समस्त आवेदनों में वांछित सूचनाएं माननीय उच्चतम न्यायालय द्वारा सिविल अपील संख्या 6454/ 2011, Central Board of Secondary Education & Anr. बनाम Aditya Bandopadhyay & Ors. मामले में प्रदत्त निर्णय दिनांक 09.08.2011 के आलोक में सूचनाएं प्रदान किया जाना समीचीन नहीं है, तदनुसार उक्त समस्त आवेदन खारिज किये जाते हैं।

5. On-going through the applications filed by you it comes out that you are not interested in seeking information relevant to some specific point of public interest. Rather you have sought information with respect to almost each and every aspect of working of the department and that too, in a manner as if you have to ensure overall effective supervision of the working of the department. The manner in which the information has been sought indicates as if you are either interested in ensuring that the department is functioning and managing

its affairs with regard to different aspects of working effectively or trying to collect and collate information for doing an exhaustive research on the working of the department. The RTI Act mandates obtaining of information of public interest from a public authority which is otherwise not available to the person interested in obtaining such information. The objective is to ensure that information of public interest is suitably disclosed in public interest. But this does not mean that detailed information with regard to each and every aspect of the working of the public authority has to be collected, tabulated and provided to you. Such an exercise to provide the desired information would result in the human resources of the department having to be devoted to consult almost each and every file to prepare the information. Certainly, that has not been the objective of the RTI Act. If you are interested in getting information with any specific matter you may obtain such information or you may visit the office of the public authority to inspect the relevant file to ascertain as to what documents or which information you want to obtain in public interest.

6. The information sought indicates that public interest is lacking in the instant application. While deciding the Writ Petition No. 7976/2020 vide judgment dated 12.01.2021, Hon'ble Delhi High Court has laid down a principle which is relevant to the instant application. The Hon'ble Court observed thus. "this court is of opinion that whenever information is sought under the RTI Act, the disclosure of interest in the information sought would be necessary". The instant applications lack the disclosure of public interest especially when seen in the light of the aspects covered and the magnitude of information sought.

6.2. Keeping in view the pronouncements of Hon ble Delhi High Court and Hon'ble Supreme Court and the provisions of the RTI Act including the principle of disclosure of public interest, the instant applications filed by you are hereby rejected.

7. इस प्रकार उपर्युक्त उक्त आर टी आई आवेदनों का निस्तारण किया जाता है। आवेदक इस आदेश के खिलाफ अपर आयुक्त और प्रथम अपीलीय अधिकारी (आरटीआई), सी. जी. एस. टी. (अंकेक्षण) आयुक्तालय, जी-105, गली न. 5, नव जोधपुर औद्योगिक क्षेत्र, बासनी, जोधपुर को आदेश प्राप्ति के 30 दिन में अपील कर सकते हैं।
