केंद्रीय अप्रत्यक्ष कर एवं सीमा शुल्क बोर्ड (CBIC), नई दिल्ली ने ई-मेल दिनांक 03.07.2026 के माध्यम से कर्मचारी चयन आयोग द्वारा आयोजित संयुक्त स्नातक स्तरीय परीक्षा, 2025 के परिणामों के आधार पर केंद्रीय वस्तु और सेवाकर अंचल, जयपुर में निरीक्षक (सी.जी.एस.टी./ केंद्रीय उत्पाद शुल्क) के पद पर 30 अभ्यर्थियों को दस्तावेज सत्यापन / शारीरिक क्षमता परीक्षा/ स्वास्थ्य परीक्षा हेतु आवंटित किया है।

Central Board of Indirect Taxes and Customs (CBIC), New Delhi vide email dated 03.07.2026 has assigned 30 candidates for the post of **Inspector (CGST/Central Excise)** to CGST & Central Excise (Jaipur Zone), Jaipur to conduct their documents verification/physical test/medical examination based on the result of the Combined Graduate Level Examination, 2025 conducted by Staff Selection Commission.

2. जी.एस.आर. 1172(ई) दिनांक 26.12.2016 के अनुसार निरीक्षक (केंद्रीय उत्पाद शुल्क)/निवारक अधिकारी/परीक्षक पदों की श्रेणी में नियुक्ति के लिए अभ्यर्थियों को निम्नलिखित शारीरिक क्षमता परीक्षा उत्तीर्ण करना और उनका निम्नलिखित शारीरिक मानकों के अनुरूप होना आवश्यक है।

As per G.S.R. 1172(E) dated 26.12.2016, the candidates are required to pass physical test and possess physical standard as described below, for appointment to the grade of Inspector (**Central Excise**) / **Preventive Officer** / **Examiner**.

Candidates are advised to plan their itinerary for at least 3-4 days so as to attend DV, PET and Medical Examination. **Candidates should make their own arrangement for procuring bicycle for undergoing the Physical Test. Candidates are requested to bring shoes for the Physical Test.** The process of Document Verification/ Physical Test/Medical Examination is subject to receipt and verification of dossiers by the designated authority in the Zone.
