In terms of Central Board of Indirect Taxes & Customs New Delhi's letter F. No. CBIC-30C-18(13)/30/2023-Ad-IIIB Section – CBEC dated 22nd May 2025 readwith Staff Selection Commission, New Delhi's letter F. No. 2/223/2018-Legal (ND-I) dated 14th May 2025, the revised seniority list in the grade of Inspectors as on 31.12.2010 has been issued, vide this office letter No. GCCO/II/34/4/2025/ADMN/ dated 4th June 2025. Seniority lists in the grade of Inspectors issued after 31.12.2010 have also been revised to the extent of the revised seniority of Inspectors as on 31.12.2010, vide the aforesaid letter dated 4th June 2025.

2. Consequent upon the revision of seniority lists of Inspectors, promotions for the vacancy years 2018, 2020, 2021, 2022, 2023, 2024 and 2025, were reviewed.

3.2 Shri Amitabh Yadav should submit joining report to his controlling officer under intimation to this office. Shri Amitabh Yadav should be allowed to join the promoted post, if clear from the vigilance angle. His promotion is made on "IN-SITU" basis i.e. he shall continue to work at the same place where he is presently posted till his posting orders as Superintendent, Group 'B' (Gazetted) is issued by the Competent Authority.

3.3 On the aforesaid notional promotion to the grade of Superintendent, Group 'B' (Gazetted) on regular basis, pay of Shri Amitabh Yadav should be fixed under F.R. 27 but no arrears would be admissible till date of his joining in the grade of Superintendent, Group 'B' (Gazetted) in terms of Para 18.4.3 of the DPC guidelines regarding review DPC.

6.2 Further, Non-Functional Upgradation to the grade pay of Rs. 5400 in PB-2 (Revised as Level-9 in Pay Matrix Rs. 53100-167800 granted to Shri Hemant Kumar Arora, Superintendent, CGST Jaipur w.e.f. 23.12.2024, vide this office Establishment Order No. CCU-11/2025 dated 3rd February 2025, is hereby withdrawn.

7. On promotion, benefit of option for fixation of pay in the promotional post, if admissible, shall be available to the officers named above in terms of provisions contained in the DoPT's O.M. No. DOPT-1667551701810 dated 13th September 2022. They may exercise the option, if benefit of the same is admissible, within one month from the date of their promotion. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

8. The promotion of the aforesaid officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the Jarnail Singh batch of cases in the matter of reservation in promotion.

9. The promotion of the aforesaid officers is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

10. The aforesaid promotion is also subject to the final outcome with reference to Board's letter F. No. A.32022/67/2018-Ad.IIIA, dated 12th June 2025.

11. The promotion of the aforesaid officers is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.
