Consequent upon the recommendations of the DPC Meeting held on 31.05.2021 for promotion to the grade of Administrative Officer, Group 'B' Gazetted, Ministerial and expiry of penalty period on 01.12.2021 in respect of Shri Narendra Singh (DOB – 18.11.1968), Executive Assistant, CGST & CX Commissionerate, Jodhpur, he is hereby promoted to the grade of Administrative Officer, Group 'B' Gazetted, Ministerial, in Level-7 of the Pay Matrix Rs. 44,900/- to Rs. 1,42,000/- plus other allowances, as admissible on regular basis with effect from his date of joining in pursuance of this order.

2. The said officer should submit his joining report on the said regular promotion to the concerned controlling officer under intimation to this office immediately. 4. The aforesaid promotion of the said officer is subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial form.

5. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.
