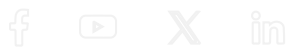

Please refer to your RTI application Registration No. GSTJP/R/E/24/00127 dated 02.09.2024 for providing information under the RTI Act, 2005.

With reference to the information sought by you in your above mentioned RTI application, the reply in respect of CGST Jaipur Zone is as under:-

**Point No. 01:** The information sought regarding “You are requested to please tell me my actual aadhaar authentication date.”, is not maintained, hence cannot be provided in this regard Hon’ble CIC in the case of Shri Devi Ram v/s Telecom Regulatory authority of India dated 01.08.2008 has held that information which are not maintained cannot be obtained u/s 2(f) of the Act.

Further the remaining part of the information sought “Why it current visible date (18 July 2024) is different from Actual date of aadhaar authentication which is 23 August 2021 according to my records and logs. And do you consider email updates as aadhaar authentication on GST Portal.”, is not covered under the definition of information as per Section 2(f) of the RTI Act, 2005 as detailed below:-

**Section 2(f) of the RTI Act, 2005:-**

(f) “information” means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.

If you are not satisfied with above reply, you may prefer an appeal against the reply within 30 days of receipt of this reply to The Appellate Authority and Additional Commissioner, Office of the Chief Commissioner, CGST & Central Excise (JZ) Jaipur, New Central Revenue Building, Statue Circle, C-Scheme, Jaipur-302005.
