3. Please mention under which Recruitment Rules the aforementioned promotions (convened in 2016, 2017, and 2018) were processed and considered.

Point 1 to 3: - *“Certified copies of the minutes of Departmental Promotion Committee (DPC) meetings held on 17.05.2017 and 31.05.2018 for promotion to the grade of Inspector are enclosed. Certified copies of the post based reservation roster for the Inspector cadre as on 31.12.2016 & copies of relevant note sheets are also enclosed. In terms of instructions contained in O.M. No. 36012/17/88- Estt. (SCT) dated 25.04.1989, reservation in posts by promotion should be made applicable to all grades or services, in which the element of direct recruitment, if any, does not exceed 75%. Since, as per RR 2016 of Inspector grade, 90% of vacancies are to be filled by direct recruitments, provisions of reservation are not applicable.”*

This DPC/Review DPC has been informed vide Self Contained Note that DPC/Review DPC is to be held in respect of DPCs/Review DPC held on 09.05.2014/15.10.2014/21.11.2014 for the vacancy year 2014-2015 and also a fresh DPC is to be held for the vacancy year 2016-2017.

2. In terms of Ministry's letter F.No. A.32018/44/2016-Ad.III(A) dated 13.01.2017, old RRs of Stenographer Grade-I, 2004 and other related instructions, following 9 Stenographers Grade-II were granted notional promotion to the grade of Stenographer Grade-I w.e.f. their date of eligibility for the relevant vacancy years vide this office Esstt. Order No. 20/2017 dated 15.02.2017 :

3. Further, with reference to the representations received from aforesaid Stenographers Grade-I for promotion to the grade of Inspector clarifications on following points were sought from the Ministry by this office vide letter C.No. II-3(3)CCU/JZ/2016/5807 dated 20.03.2017:

(1) Whether the period of notional promotion granted to the Stenographers Grade-I in pursuance of the CBEC's letter dated 13.01.2017 will be counted for the purpose of promotion to the grade of Inspector.

(2) Whether the said Stenographers are also eligible for grant of notional promotion to the grade of Inspector from the date of eligibility for the relevant vacancy years even if non-availability of vacancies in the grade of Inspector under promotion quota in the relevant vacancy year.

The Ministry vide letter F.No.32018/44/2016-Ad.(III)A dated 11.04.2017 has clarified that the period of notional promotion granted to the said Stenographers Grade-I in pursuance of the CBEC's letter dated 13.01.2017 will be counted for the purpose of promotion to the grade of Inspector. Further with reference to the 2nd point of aforesaid letter, Ministry also clarified that the said Stenographers cannot be promoted to the grade of Inspector from the date of eligibility for the relevant vacancy year because of non-availability of vacancies in the grade of Inspector under promotion quota. The promotion can be granted only w.e.f. the date of the occurrence of vacancy in the relevant vacancy year in the grade of Inspector as per their eligibility.

4. After examination of the matter in light of the Ministry's aforesaid letter dated 11.04.2017, the Administration has decided to consider the cases of eligible Stenographers Grade-I for promotion to the grade of Inspector against the available vacancies during the vacancy year 2014-2015 by conducting review DPC in respect of DPCs/Review DPC held on 09.05.2014/15.10.2014/21.11.2014 for the vacancy year 2014-2015 and also decided to conduct fresh DPC for the vacancy year 2016-2017 for filling up the vacancies available prior to 26.12.2016 in accordance with the old RRs of Inspector, 2002.

5. The Ministry vide letter F.No. A.12018/30/2003.AD.III.B dated 29.12.2016 forwarded the amended Recruitment Rules of Inspector, 2016 issued vide Notification dated 26.12.2016 in supersession of the Recruitment Rules of Inspector, 2002. Hence, the old RRs of Inspector, 2002 were applicable upto 25.12.2016 and the amended RRs of Inspector, 2016 are applicable with effect from 26.12.2016.

6(i) As per the old Recruitment Rules of Inspector, 2002 forwarded by the Ministry vide letter F.No. A-12034/04/2002-Ad.III.V dated 07.06.2003, 66.67% and 33.33% of vacancies in the grade were filled up by direct recruitment and promotion respectively.

(ii) As per clauses 12 (b) and (c) of the schedule of the said old Recruitment Rules, the **period of qualifying service** in the feeder cadres for consideration for promotion to the grade of Inspector (Grade Pay Rs. 4600 in PB-2) was prescribed as under :-

(iii) Further, as per Note-2 of column 12 of old RRs of Inspector, the candidates were required to pass such written test as may be determined by the CBEC from time to time.

7. The Ministry vide letter F.No.A-32018/14/95-Ad.II-A dated 20.07.95 and letter F.No.A-32011/25/2000-Ad.III.A dated 27.06.2000 clarified that, (i) all the eligible Tax-Assistants will be placed enbloc above the UDC, all the eligible Steno Gr.II will be placed enbloc above the Stenographer Gr. III in the combined consideration list, this will be subject to maintenance of their inter-se-seniority in the respective grades. (ii) the combined consideration list of all the eligible cadres viz. Tax-Assistant/ Stenographer Grade-II/UDC/Stenographer Grade-III shall be prepared on the basis of the date of their completion of qualifying service in the respective grades subject to maintenance of inter-se-seniority and condition indicated in (i) above.

8. The details of DPCs/ Review DPC held for promotion to the grade of Inspector for filling up the vacancies for the vacancy years 2014-2015 and 2015-2016 and vacancy position in the grade of Inspector under promotion quota for the vacancy years 2014-2015, 2015-2016 and 2016-2017, are as under :

9. As per para 18.4.3 of the DPC guidelines, if the officers placed junior to the officer concerned have been promoted, he should be promoted immediately and if there is no vacancy, the junior most person officiating in the higher grade should be reverted to accommodate him. On promotion, his pay should be fixed under FR 27 at the stage it would have reached, had he been promoted from the date of the officer immediately below him was promoted but no arrears would be admissible. The seniority of the officer would be determined in the order in which his name, on review, has been placed in the select list by the DPC. It is submitted that there is no need to revert any officer as sufficient number of vacancies are already available under promotion quota in the cadre of Inspector.

10(i) Shri Dinesh Kumar, Stenographer Grade-I (mentioned at Sl. No. 2 in the chart shown in above para-2) has completed 2 years of service in the grade as on 01.01.2013 but he has not passed the required departmental examination for promotion to the grade of Inspector so far, therefore, he is not eligible for consideration for promotion to the grade of Inspector. Further, Shri Sunil Kumar Gupta, Stenographer Grade-I (mentioned at Sl. No. 9 in the chart shown in above para-2) has passed the departmental examination for promotion to the grade of Inspector on 27.09.2012 but he has not completed the required 2 years service in the grade as on 01.04.2016, therefore, he is also not eligible for consideration for promotion to the grade of Inspector against the vacancies for the vacancy years 2014-2015, 2015-2016 and 2016-2017 in accordance with the old RRs of Inspector, 2002 which were applicable upto 25.12.2016.

(ii) As mentioned in the Self Contained Note in para 9 and 10, 7 Stenographers Grade-I and one Senior Tax Assistants (Now EA) namely Shri Amit Kumar Srivastava who has completed 2 years regular service in the grade of STA/Stenographers Grade-I and passed the departmental Examination and also passed the physical test, are eligible for consideration for promotion to the grade of Inspector for the panel/vacancy years 2014-2015 and 2016-2017.

11(i) As per Note-3 of column 12 of Recruitment Rules of Inspector, 2002 candidates shall be required to pass **physical tests** and confirm the physical standards as specified in column 8. Further, a physical test was conducted on 17.05.2017 in respect of 9 candidates for regular promotion to the grade of Inspector. Since, Shri Raghuvveer Singh, STA remained absent in the physical test held on 17.05.2017, therefore, he has not been considered for promotion to the grade of Inspector by this DPC.

12 (i) As per Note-4 *ibid*, the eligible officers shall be required to pass through an **interview** before promotion.

(ii) The Ministry vide letter F.No. A.12034/SSC/07/2015.AD.IIIB dated 20.02.2017, instructed not to hold interview for Group 'B' (Non-Gazetted) posts for promotees. Further, the Ministry vide letter F.No. A.12034/SSC/07/2015.AD.IIIB dated 18.04.2017 instructed that the effective date of discontinuation of Interview for Group 'B' posts for promotees should be considered from **01.01.2016**. Accordingly, interviews was taken in respect of the officers who have been considered for promotion to the grade of Inspector by this Review DPCs in respect of DPCs dated 09.05.2014, 15.10.2014 and Review DPC dated 21.11.2014. Further, there is no need of interview in respect of officers who have been considered for promotion for the panel/vacancy year 2016-2017 by fresh DPC.

13. In view of the above, following Review DPCs/DPC, have been held for grant of notional promotion to the grade of Inspector :

(i) Review DCP in respect of DPC dated 09.05.2014/Review DPC dated 21.11.2014 for consideration the case of Shri Manoj Kumar Bairwa (SC), Stenographer Grade-I.

(iii) Fresh DPC for the Vacancy Year 2016-2017 for consideration the cases of Shri Amit Kumar Srivastava STA (Now EA) and S/Shri Naresh Kumar Pal, Dungar Singh, Santosh Kumar Bairwa (SC), Stenographer Grade-I. Accordingly, the said STA/Stenographers Grade-I have been considered for notional promotion to the grade of Inspector.

15. As per the Recruitment Rules, the vacancies in the grade of Inspector are to be filled up by Selection method. As per the instructions contained in the DOPT's O.M. No.22011/2/2002 Estt (D) dated 06.01.2006 regarding size of zone of consideration for promotion by 'Selection' method, the normal zone of consideration for filling up 60 regular vacancies is 93 but in terms of the Recruitment Rules, 2002 and other related instructions, there are only 4 eligible candidates {(3 Stenographers Grade-I + 1 Senior Tax Assistant (Now EA) for consideration for regular promotion to the grade of Inspector, Group 'B' (Non-Gazetted))} for the panel/vacancy year 2016-2017. Accordingly, 4 candidates {3 Stenographer Grade-I (erstwhile Stenographer Grade-II) and one Senior Tax Assistant (now EA)} who have completed 2 years regular service in the grade of Stenographer Grade-I / Senior Tax Assistant, passed the departmental examination as on 01.04.2016 and passed the physical test, have been taken in to consideration for promotion to the grade of Inspector, Group 'B' (Non-Gazetted) for filling up 60 vacancies (48 UR + 12 SC).

(ii) As per the Recruitment Rules of Inspector read with Ministry's letter F. No. A-32018/05/2008-Ad.III.A dated 27.08.2008, the post of Inspector is to be filled by **Selection method**. The Ministry vide aforesaid letter dated 27.08.2008 decided that, the following system shall be followed for promotion to the post of Inspector:

"There shall be no marks prescribed for assessment of ACRs. The ACRs will continue to be assessed as 'Good', 'Very Good', 'Outstanding' etc. The officials meeting the benchmark of 'Good' shall be treated as 'fit' for promotion. The examination shall be qualifying as per existing practice and marks obtained in the exams shall not determine the seniority. The Interview Board shall also assess the suitability or otherwise, of the candidate for holding the post of Inspector, without awarding comparative marks. Thus, at the end of the selection procedure, each official considered for the promotion shall be assessed as 'fit' or 'unfit'. The officials

assessed as 'fit' shall be arranged in the order of their seniority in the feeder grade, without any supersession."

(iii) As per Ministry's letter F. No. A-32018/37/2008-Ad.III.A dated 15.01.2009, the candidates found fit in the interview are to be selected for promotion to the grade of Inspector as the same is a part of the process for promotion to the grade of Inspector.

17. As per point No. (iv) of CBEC's letter F. No. A-32011/2/90-AD.III.A dated 11.07.1990, the composition of the Interview Board and the DPC should be identical. However, assessment of CCRs should not be made before interviews are conducted in order to ensure that the interview board is not prejudiced by the CCRs' assessment.

18. As per para (2) of the Ministry of Personnel, Public Grievances & Pension's O.M. No.22011/4/91-Estt.(A), dated 14.09.1992, in respect of the Government Servants – (a) who are under suspension, (b) to whom a charge-sheet has been issued and the disciplinary proceedings are pending, and (c) against whom prosecution for a criminal charge is pending, the DPC shall assess their suitability along with other eligible candidates without taking into consideration the disciplinary case / criminal prosecution pending. The assessment of the DPC, including 'Unfit for promotion' and the grading awarded by it will be kept in a sealed cover.

19 (i). As per para 6.2.1(c) of the DPC guidelines, where one or more CRs have not been written for any reason during the relevant period, the DPC should consider the CRs of the years preceding the period in question and if in any case even these years are not available, the DPC should take the CRs of the lower grade into account to complete the number of CRs required to be considered, if this is also not possible, all the available CRs should be taken into account.

(ii) As per para 6.2.1(e) of the DPC guidelines, the DPC should not be guided merely by the overall grading, if any, that may be recorded in the CRs but should make its own assessment on the basis of the entries in the CRs, because it has been noticed that sometimes the overall grading in a CR may be inconsistent with the grading under various parameters or attributes.

(iii) As per DOPT's O.M. No. 22011/9/98/Estt.(D) dated 16.06.2000, ACRs upto the year 2012-2013 and 2014-2015 have been taken into consideration irrespective of the date of convening of DPC for the panel/vacancy years 2014-2015 and 2016-2017 respectively and as per DOPT's O.M. No. 22011/7/98-Estt.(D) dated 06.10.2000, the DPC should assess the suitability of the employees for promotion on the basis of their service records and with particular reference to the CRs for 5 preceding years irrespective of the qualifying service prescribed in the Service / Recruitment Rules.

20. As per para 18.1 of the DPC guidelines, the proceedings of any DPC may be reviewed where eligible persons were omitted to be considered for promotion to the higher cadres. The other related Rules and Regulations in the matter are placed in the main folders of the DPCs held 09.05.2014, 15.10.2014 and 21.11.2014.

21. As per the criterion adopted for making selection by the DPCs/Review DPC held on 09.05.2014, 15.10.2014 and 21.11.2014, the candidates whose gradings in all 5 ACRs are atleast 'Good' without any adverse remarks and found fit/pass in physical test as well as in interview, have been graded as 'Fit' for promotion to the grade of Inspector. The candidates whose gradings are less than 'Good' in one or more ACR out of 5 ACRs or with any adverse remarks in any ACR(s) or found Unfit/fail in the interview, have been graded as 'Unfit' for promotion by the present Review DPC.

The CBEC vide letter F.No. A.12018/30/2003-Ad.III.B(Pt.) dated 22.09.2017, it is clarified that as informed by the UPSC, two terms "Limited Departmental Competitive Examination (LDCE) and "Departmental Qualifying Examination" used w.r.t. promotion in column 10 and column 11 in the Recruitment Rules notified vide G.S.R. 1172 (E) dated 26.12.2016 are the same and may be used interchangeably.

(v) As per Note-4 of column 11 of Recruitment Rules of Inspector, 2016, candidates shall be required to pass **physical tests prescribed for direct recruits under column (7)**. Accordingly, a physical test was conducted by the committee nominated for the said purpose by the competent authority on 29.05.2018 for the only one eligible candidate i.e. Sh. Avinash Kumar Sharma, Stenographer Grade-I for regular promotion to the grade of Inspector. The Ministry vide letter F.No.32018/44/2016-Ad.(III)A dated 11.04.2017 has further clarified that the period of notional promotion granted to the said Stenographers Grade-I in pursuance of the CBEC's letter dated 13.01.2017 will be counted for the purpose of promotion to the grade of Inspector. As per Ministry's above clarification dated 11.04.17 eligibility of Shri Avinash Kumar Sharma Stenographer-I have been taken from the date of his notional promotion to the grade of Steno Grade-I i.e. 01.01.2011. In terms new Recruitment Rules, 2016 and as per clarification of Ministry dated 11.04.2017, Shri Avinash Kumar Sharma has completed more than five years service as on crucial date 01.04.2018 for the transitional penal/vacancy year 2018 and he is eligible for consideration for promotion to the post of Inspector.

9. Sh. Avinash Kumar Sharma (DOB 21.03.1987), Stenographer Grade-I was earlier promoted to the grade of Inspector vide this office Estt. Order No. 64/2017 dated 18.05.2017 in pursuance of Ministry's letter F.No. 32018/44/2016-Ad.III(A) dated 11.04.2017 and other related instruction issued by the DOP/Ministry from time to time by the Review DPC/DPC held on 17.05.2017. Sh. Avinash Kumar Sharma, Stenographer Grade-I vide letter dated 29.05.2017 had requested to forego his said promotion due to the reasons mentioned in his request letter dated 29.05.2017. Being an appointing authority for the post of Group "B" (Non-Gazetted Posts), the Commissioner, Central Excise Commissionerate, Jaipur has accepted his promotion forgo request to the post of Inspector (Gr. B non-Gazetted) accorded to him vide this zone Establishment

Order 64/2017 dated 18.05.2017 and he has been debarred for further promotion to the grade of Inspector upto 28.05.2018 or next vacancy arises in the grade, whichever is later vide E.O. No. 72/2017 dated 02.06.2017. The debarred period has expired on 28.05.2018. Therefore this meeting of DPC is to be scheduled for promotion of only one eligible candidate i.e. Shri Avinash Kumar Sharma, Steno Grade-I for the penal vacancy year 2018 (01.04.18 to 31.12.18).

10. The cadre of Women Searcher and Draftsman are not available in Jaipur Zone, Jaipur. Moreover, Executive Assistant or Stenographer Grade-I with fifteen years combined regular service in level-6 in the pay matrix (Rs.35,400-1,12,400) and in level-4 in the pay matrix (Rs.25,500-81,100) and Tax Assistant and Stenographer Grade-II in level-4 in the pay matrix (Rs.25,500-81,100) with fifteen years regular service in the grade are not eligible/available for consideration for promotion to the post of Inspector.

11. As per the DOPT's O.M. No. 36012/17/88-Estt.(SCT), dated 25.04.1989, there will be reservation at 15% and 7.5% of the vacancies for the SC and ST respectively in promotions made by selection in the grades or services in which the element of direct recruitment, if any does not exceed 75%. As per new Recruitment Rules, 2016 made effective w.e.f. 26.12.2016 for the post of Inspector, as per Col. No. 10, since, 90% vacancies (exceed 75%) in the grade of Inspector are to be filled up by direct recruitment and 10% vacancies are to be filled up by promotion, therefore, no reservation for SC/ST category is applicable in promotion quota vacancies to the grade of Inspector.

12. In terms of the DOPT's OM No.22011/6/2013-Estt(D) dated 28.05.2014, the crucial date for determining the eligibility of the officers shall be 1st April of the vacancy year in case of financial year based vacancy year i.e. where the APARs are written financial year-wise. Further, DOPT vide OM No. 22011/4/2013-Estt.(D) dated 08.05.2017 vacancy year shifted to Calendar year from the year 2018 onwards where the financial year based vacancy year being followed. Further, the year 2018 being the transitional year, the vacancy period shall be 1st April, 2018 to 31st December, 2018. The crucial date of eligibility shall be 1st April, 2018 for the transactional year 2018. In terms of above OMs, the crucial date for determining the eligibility of the officers for promotion to the grade of Inspector, Group 'B' (Non-Gazetted) for the transitional panel/vacancy year 2018 (01.04.2018 to 31.12.2018) is 01.04.2018.

13. As on date there are total 85 vacancies in the cadre of Inspector are available and one vacancy would arise on 01.7.2018 due to retirement of one officer namely Sh. Laxman Singh on 30.06.2018. Thus, there would be total 86 vacancies available in the cadre of Inspector for the penal/vacancy year 2018 (01.04.2018 to 31.12.2018). Out of these 86 vacancies, there are 63.20 (rounded 63) vacancies would be available under promotion quota in the cadre of Inspector, Group 'B' (Non-Gazetted) for the penal/vacancy year 2018 (01.04.2018 to 31.12.2018).

14. The Ministry vide letter F.No. A.12034/SSC/07/2015.AD.IIIB dated 20.02.2017, instructed not to hold interview for Group 'B' (Non-Gazetted) posts for promotees. Further, the Ministry vide letter F.No. A.12034/SSC/07/2015.AD.IIIB dated 18.04.2017 instructed that the effective date of discontinuation of interview for Group 'B' posts for promotees should be considered from 01.01.2016. Hence, there are no needs to hold interview in respect of officers who are to be considered for promotion for the panel/vacancy year 2018 (01.04.2018 to 31.12.2018).

15. As per the Recruitment Rules, the vacancies in the grade of Inspector are to be filled up by Selection method. As per the instructions contained in the DOPT's O.M. No.22011/2/2002 Estt (D) dated 06.01.2006 regarding size of zone of consideration for promotion by 'Selection' method, the normal zone of

consideration for filling up 63 regular vacancies is 98 but in terms of the Recruitment Rules, 2016 and other related instructions, there is only one eligible candidate namely Shri Avinash Kumar Sharma, Stenographer Gr.-I is available w.e.f. the date 29.05.2018 (i.e. after expiry of debarred period for promotion to the grade of Inspector as per E.O. No.72/2017 dated 02.06.2017) for consideration for regular promotion to the grade of Inspector, Group 'B' (Non-Gazetted) for the panel/vacancy year 2018 (01.04.2018 to 31.12.2018). Sh. Avinash Kumar Sharma has passed the physical test conducted on 29.05.2018 by the committee nominated for the said purpose by the competent authority, have been taken for consideration for promotion to the grade of Inspector, Group 'B' (Non-Gazetted).

16. As per para-3.4 of DOPT's O.M. No.35034/7/97-Estt.(D) dated 08.02.2002 forwarded by the Ministry under letter F.No.A-32011/42/2002/Ad.III-A dated 25.09.2002, promotion to the grade of **below** the pay scales of Rs.12000-16500 (revised as Rs. 15600-39100 with the grade pay of Rs. 7600 in PB-3) shall be "Selection", the bench mark for promotion, shall continue to be 'Good' and the DPC shall grade the Officer as 'Fit' or 'Unfit' only w.r.t. the bench mark of 'Good' only. Those who are graded as 'Fit' shall be included in the select panel prepared by the DPC in order of their inter-se-seniority in the feeder grade.

17. As per para (2) of the Ministry of Personnel, Public Grievances & Pension's O.M. No.22011/4/91-Estt.(A), dated 14.09.1992, in respect of the Government Servants – (a) who are under suspension, (b) to whom a charge-sheet has been issued and the disciplinary proceedings are pending, and (c) against whom prosecution for a criminal charge is pending, the DPC shall assess their suitability along with other eligible candidates without taking into consideration the disciplinary case / criminal prosecution pending. The assessment of the DPC, including 'Unfit for promotion' and the grading awarded by it will be kept in a sealed cover.

18 (i). As per para 6.2.1(c) of the DPC guidelines, where one or more CRs have not been written for any reason during the relevant period, the DPC should consider the CRs of the years preceding the period in question and if in any case even these years are not available, the DPC should take the CRs of the lower grade into account to complete the number of CRs required to be considered, if this is also not possible, all the available CRs should be taken into account.

(ii) As per para 6.2.1(e) of the DPC guidelines, the DPC should not be guided merely by the overall grading, if any, that may be recorded in the CRs but should make its own assessment on the basis of the entries in the CRs, because it has been noticed that sometimes the overall grading in a CR may be inconsistent with the grading under various parameters or attributes.

(iii) As per DOPT's O.M. No.22011/9/98/Estt.(D) dated 16.06.2000 readwith DOPT's O.M. No. 22011/4/2013-Estt. (D) dated 08.05.2017, for the vacancy year 2018 (01.04.2018 to 31.12.2018), 5 year ACRs upto the year 2015-2016 are required to be considered irrespective of the date of convening of DPC and as per DOPT's O.M. No.22011/7/98-Estt.(D) dated 06.10.2000, the DPC should assess the suitability of the employees for promotion on the basis of their service records and with particular reference to the CRs for 5 preceding years irrespective of the qualifying service prescribed in the Service / Recruitment Rules.

19. According to above, the criterion adopted for making selection by the DPC, that candidate's grading in all 5 ACRs must be atleast 'Good' without any adverse remarks and should have passed the physical test as norms prescribed in RR's 2016 of Inspector, may be considered for grading as 'Fit' for promotion to the grade of Inspector.

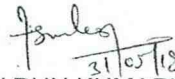

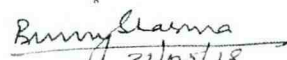

Kindly peruse the note on notesheet pre page. It is submitted that there are 60 existing vacancies (48 UR, 12 SC and ST-0) in the grade of Inspector under promotion quota for the panel/vacancy year 2016-17. As per verbal directions of the Chief Commissioner, meeting of review DPC/ fresh DPC for promotion to the grade of Inspector from feeder cadre i.e. STA/stenographer-I is scheduled to be held in next week.

As per Note-3 (Page-118/c) of column 12 of Recruitment Rules of Inspector, 2002 candidates shall be required to pass **physical tests** and confirm the physical standards as specified in column 8. Further, as per Note-4 ibid, the eligible officers shall be required to pass through an **interview** before promotion.

It is submitted that as per Ministry's letter F.No. A.12034/SSC/07/2015.AD.IIIB dated 20.02.2017 (P.128/c), it has been instructed that not to hold interview for Group 'B' (Non-Gazetted) posts for promotees. Further, the Ministry vide letter F.No. A.12034/SSC/07/2015.AD.IIIB dated 18.04.2017 (P.122/c) instructed that the effective date of discontinuation of Interview for Group 'B' posts for promotees should be considered from **01.01.2016**.
