Applications are invited from the aspiring eligible advocates, who qualified in terms of Section 24(8) of the Criminal Procedure Code, 1973 to the Bar Council of the High Court/Bar Association of Subordinate Courts, for selection of Special Public Prosecutor (SPPs) for handling CBIC (Central Board of Indirect Taxes & Customs) cases before the Subordinate Court/Court of Session and High Court.

2. The applicants should apply alongwith the Bio-Data in Performa-A and willingness to the Principal Commissioner of CGST & Central Excise Commissionerate, New Central Revenue Building, Statue Circle, C-Scheme, Jaipur-302005 by 15.09.2021. The existing SPPs seeking extension should also apply afresh. The Proforma-A can also be downloaded from the website <https://cgstjaipur.gov.in> (Trade Notice/Public Notice Section).

3. The first engagement of an SPP shall normally be for a period of 18 Months. Such engagement will be renewable on receipt of recommendation of the concerned Chief Commissioner alongwith the annual performance appraisal on completion of first 12 months of the engagement.
