With reference to the information sought by you in your above mentioned RTI application, the reply in respect of CGST Jaipur Zone is as under:-

“Point No. 1 to 3: Pertains to Central Board of Indirect Taxes & Customs, New Delhi.

Point No. 4: The vacancy in PwD category is determined on the basis of PwD Roster prepared in terms of DOPT OM No. 36035/02/2017-Estt(Res.) dated 15.01.2018. Further, in promotion quota, no reservation is applicable in terms of DOPT OM No. 36012/17-88Estt.(SCT) dated 25.04.1989.

The applicant has not mentioned cadre of which information is sought. However from Point No. 1 to 3, it appears that the information is related to cadre of Inspector.
