2. चूँकि क्रम संख्या 27, 31, 48, 57 एवं 72 से 107 पर वर्णित अधिकारियों को उनके स्वयं के अनुरोध पर स्थानांतरित किया गया है या पूर्व सामान्य वार्षिक स्थानान्तरण आदेशों के तहत प्रत्यावर्तित किया गया है, अतः, उक्त अधिकारियों के सन्दर्भ में स्थानान्तरण भत्ता एवं कार्यग्रहण अवधि देय नहीं होगी।

The officers mentioned at Sl. No. 27, 31, 48, 57 & 72 to 107 have been transferred on their own requests or have been repatriated w.r.t. earlier AGTs, therefore, they shall not be entitled for any TTA or Joining Time.
