In terms of Central Board of Indirect Taxes & Customs New Delhi's letter F. No. CBIC-30C-18(13)/30/2023-Ad-IIIB Section – CBEC dated 22nd May 2025 readwith Staff Selection Commission, New Delhi's letter F. No. 2/223/2018-Legal (ND-I) dated 14th May 2025, the revised seniority list in the grade of Inspectors as on 31.12.2010 had been issued. Consequent upon revision of seniority lists of Inspectors, Review DPC for promotion to the grade of Superintendents was conducted for the vacancy years 2018, 2020, 2021, 2022, 2023, 2024 and 2025. As per recommendations of the Review DPC, Shri Amitabh Yadav, Inspector had been notionally promoted to the Grade of Superintendent Group 'B' (Gazetted), in Level-8 of Pay Matrix Rs. 47600/- to Rs. 1,51,100/- plus other allowances, as admissible, on regular basis w.e.f. 24.07.2019 (for the vacancy year 2018) i.e. from the date of promotion of his immediate junior.

Whereas, the Board vide letter F.No. A-23011/01/2026-AD-IIA dated 03.03.2026, in compliance of Order dated 18.08.2023 of Hon'ble CAT Principal Bench, New Delhi in OA No. 1424/2018, as a consequential benefit, has allowed to extend the benefit of NFU in Grade Pay of Rs. 5400 in PB-2 (pre-revised) to Shri Amitabh Yadav, Superintendent from the date of grant of notional promotion and at par with immediate junior.

Accordingly, in pursuance of Board's letters F.No. A-26017/98/2008-Ad.IIA dated 21.11.2008, 11.02.2009, 16.09.2009 and 23.12.2009 read with Board's letter F. No. A-26017/166/2009-Ad.IIA dated 25.01.2011 and F. No. A-26017/219-2016-Ad.IIA dated 10.04.2017, Shri Amitabh Yadav, Superintendent, 'Group B' (Gazetted) (DOB – 29.12.1980), CGST Udaipur, who has completed 4 years in the grade of Superintendent, after notional promotion in the pay scale of Rs. 9300-34800 with the Grade Pay of Rs. 4800 in PB-2 (Revised as Level-8 in Pay Matrix Rs. 47600-151100) on regular basis, is hereby granted **Non-Functional Upgradation to the grade pay of Rs. 5400 in PB-2 (Revised as Level-9 in Pay Matrix Rs. 53100-167800) w.e.f. 24.07.2023.**
