Subject: Seeking information under RTI Act-2005-reg.

Kindly refer to O.M.No.36035/8/89-Estt.(SCT) dated 20.11.1989 regarding reservation for physically handicapped in the posts(Group C & D) filled by promotion. Further, the Senior Tax Assistant (Group-C) Recruitment Rule dated 02.09.2003 may kindly be referred. In this context, it is submitted that in a RTI reply, the CBIC, New Delhi has intimated that RRs of Executive Assistant (Gr. B post) (2015) is self-explanatory which has superseded the RRs of STA (Gr. C post)-2003. In the light of above, it is quite clear that STA/EA post was Group-C post till 28.09.2015 i.e. till the date when RRs of EA was published in official Gazette.

As per above details, the following information may kindly be provided under RTI Act-2005.

1-Number of posts reserved regarding Person with Disabilities for promotion of Tax Assistant to the Grade of Senior Tax Assistant (Group-C) post for the panel year 2013-14 & 2014-15 across the CBIC may kindly be provided.

2- Kindly take note of DGHRD, CBIC, New Delhi letter F.No.8/B/20/HRD(HRM-1)/Misc/2023/9459 dated 29.12.2023 regarding inclusion of PwBD Candidates in the AISLs of all three feeder cadres for promotion to the grade of Assistant Commissioner against the vacancy year 2013-14 to 2023. In this regard, the total number of Superintendent in PwBD category who have been either promoted to the grade of Assistant Commissioner or included in AISLs of Superintendent for Promotion to the Grade of Assistant Commissioner may kindly be provided.

3-Kindly take note of DoPT OM No.36012/1/2020-Estt(Res-II) dated 28.12.2023 regarding reservation in promotion to PwBDs candidates on notional basis w.e.f.30.06.2016. In this regard, the total number of PwBDs candidates who have been promoted notionally w.e.f 30.06.2016 from the grade of TA to EA, EA to Inspector & Inspector to Superintendent across the CBIC up to 17.05.2022 may kindly be provided.

4- Number of officers who have been granted '**REGULAR NOTIONAL PROMOTION**' in the grade of STA/EA, Inspector, Superintendent & Assistant Commissioner from the date of their eligibility as per Hon'ble Supreme Court order dated 12.02.2024 passed in Contempt petition(Civil) No.873/2023 in W.P.(C) No. 521/2008 filed by Shri Shanmuga Sundaram may kindly be provided.

In this regard, it is requested that the above information may kindly be provided in online mode if found in order.
