ESTABLISHMENT ORDER NO. CCU- 28/2026

In terms of Central Board of Indirect Taxes & Customs, New Delhi's letter F. No. C-18011/15/2023-Ad.II/Pt.I dated 09.01.2024 readwith DOPT's O.Ms. dated 17.05.2022 and 28.12.2023 issued under F. No. 36012/1/2020-Estt. (Res.II) regarding reservation in promotions to Persons with Benchmark Disabilities (PwBDs), a Review DPC for promotion to the grade of Superintendent for the vacancy years 2016-2017, 2020, 2021 and 2023 was held on 17.09.2024.

2. The Board vide letter F.No. CBIC-10C18(12)/12/2024-Ad-IIB Section dated 20.03.2026 has conveyed the approval of the Department of Expenditure for the creation of supernumerary posts for the duration from 30.06.2016 to 16.05.2022 i.e. for officer who had become eligible for promotion in CGST & Central Excise, Jaipur Zone during this period in light of DoPT's aforesaid O.M. dated 28.12.2023.

2. As per the recommendations of the aforesaid Review DPC dated 17.09.2024, the vacancy year and date of promotion to the grade of Superintendent in respect of following Superintendents, Group 'B' (Gazetted), is hereby revised as mentioned below in column 5:

3. On the aforesaid notional promotion to the grade of Superintendent, Group 'B' (Gazetted) of officers named at S. No. 1, 5 & 6 on regular basis, pay of the aforementioned officers should be fixed under F.R. 27 but no arrears would be admissible till date of their actual joining in the cadre of Superintendent, Group 'B' (Gazetted) in terms of Para 5 (ii) of DoPT's O.M. dated 28.12.2023 and Para 18.4.3 of the DPC guidelines regarding review DPC.

4. On promotion, benefit of option for fixation of pay in the promotional post, if admissible, shall be available to the officers named above in terms of provisions contained in the DoPT's O.M. No. DOPT-1667551701810 dated 13th September 2022. They may exercise the option, if benefit of the same is admissible, within one month from the date of their promotion. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

5. The promotion of the aforesaid officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the Jarnail Singh batch of cases in the matter of reservation in promotion.


6. The promotion of the aforesaid officers is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

7. The aforesaid promotion is also subject to the final outcome with reference to Board's letter F. No. A.32022/67/2018-Ad.IIIA, dated 12th June 2025.
