Consequent upon selection to the Post of 'Trained Graduate Teacher' in Kendriya Vidyalaya Sangathan, the resignation of Shri Jaswant Vijay Singh (DOB-12.09.1989), Inspector was technically accepted vide this office Establishment Order No. 67/2019 dated 26.09.2019 with a lien of two years and accordingly he was relieved on 26.09.2019(A.N.).

Now, considering his request dated 04.08.2021 for repatriation to this department, Shri Jaswant Vijay Singh is hereby allowed to repatriate to CGST & Central Excise Jaipur Zone as Inspector within Lien Period. However, in order to join in this department on repatriation, his resignation is required to be accepted by his present employer and he has to be duly relieved to this department. Moreover, Shri Jaswant Vijay Singh must join the department (CGST & CE Jaipur Zone) latest by 25.09.2021 after that his Lien Period will be over.

Further, consequent upon joining in CGST & Central Excise (JZ), Jaipur as Inspector on repatriation, the status of Sh. Jaswant Vijay Singh (who originally belongs to CGST & CE, Mumbai Zone-I) in CGST & Central Excise (JZ), Jaipur will be as "working on deemed loan basis" in accordance with Central Board of Indirect Taxes & Customs ' Circular issued under F.No. A-22015/117/2016-Ad.IIIA dated 20.09.2018.
