Consequent upon to the Trade Notice No.01/2017 dated 20.06.2017, 03/2017 dated 22.06.2027 and 02/2024 dated 26.11.2024 issued by the Chief Commissioner, CGST & CE, Jaipur Zone, Jaipur and Trade Notice No. 06/2017 dated 22.06.2017 & Trade Notice No.01/2024 dated 13.06.2024 issued by the Principal Commissioner, CGST Jaipur, the Trade and Industry, Taxpayer, Associations are hereby informed that the existing names of CGST Divisions falling under the Jurisdiction of Central Goods & Service Tax Commissionerate, Jaipur are being revised, as the current names which follow an alphabetic series, do not adequately reflect the specific areas under the jurisdiction of the respective Commissionerate and Divisions. The new names will help in easy identification of jurisdiction.
