8. The aforesaid promotion is also subject to the final outcome with reference to Board's letter F. No. A.32022/67/2018-Ad.IIIA, dated 12<sup>th</sup> June 2025.

9. The promotion of the aforesaid officers is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

10. The officers should be allowed to join the promoted post, if clear from the vigilance angle.
