The Orders indicating specific charge/ posting within the Commissionerates, should be issued by the respective Pr. Commissioner/ Commissioners by **19.05.2026** positively. While issuing orders for specific charge/ postings, the Transfer Policy Guidelines, 2018 (as amended), History of Postings of the officers and various instructions w.r.t. sensitive/ non-sensitive postings issued by CVC/ CVO time to time, should be kept in mind.
