Office Order No. CCU- 02 /2026

Shri Buddhi Prakash Verma was appointed on adhoc basis provisionally to the post of Wash Boy, Group 'D', in the Departmental Canteen, Central Excise, Jaipur (now Canteen Attendant, Group 'C' in the Departmental Canteen, CGST & Central Excise, Jaipur).

2. Whereas, a 'Notice of termination of service under Rule 5(1) of the Central Civil Services (Temporary Service) Rules, 1965' issued under file C. No. II-26(13)CCU/JPR/2000/4185 dated 28.10.2016 was served upon said Shri Buddhi Prakash Verma on 28.10.2016.
3. Whereas, as per the aforesaid notice dated 28.10.2016, the services of said Shri Buddhi Prakash Verma were to be stand terminated with effect from the date of expiry of a period of one month from the date of service of the said notice i.e. 28.10.2016.
4. Whereas, before expiry of notice period, the Hon'ble CAT, Jaipur vide Order dated 24.11.2016 in the O.A. No. 291/00817/2016 filed by him against aforesaid notice, as an interim directions ordered that the effect and operation of impugned notice dated 28.10.2016 shall remain in abeyance till the next date of hearing.
5. Whereas, the Ld. Tribunal vide final Order dated 26.02.2026 has dismissed the aforesaid O.A. Consequent upon the dismissal of aforesaid O.A., this office aforesaid notice dated 28.10.2016 came into force.
6. Now, therefore, it is ordered that the services of Shri Buddhi Prakash Verma, Canteen Attendant, Group 'C', Departmental Canteen, CGST & Central Excise, Jaipur are terminated with immediate effect.
