3. संबंधित प्रधान आयुक्त/आयुक्तों द्वारा अपने क्षेत्राधिकार से सम्बंधित स्थापना आदेश दिनांक **15.05.2025** तक आवश्यक रूप से जारी किए जावें। आदेश जारी करते समय, स्थानांतरण नीति दिशानिर्देश, 2018 (यथा संशोधित), अधिकारियों की पोस्टिंग का इतिहास और सीवीसी/सीवीओ द्वारा समय-समय पर जारी संवेदनशील/ असंवेदनशील पोस्टिंग के संबंध में विभिन्न निर्देशों को ध्यान में रखा जावे।

The Orders indicating specific charge/ posting within the Commissionerates, should be issued by the respective Pr. Commissioner/ Commissioners by **15.05.2025** positively.
