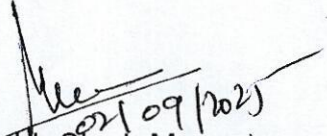

This issues with the approval of the Principal Commissioner, CGST & Central Excise, Jaipur.

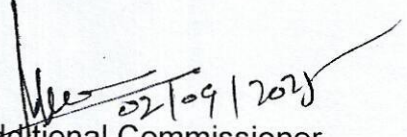
